The Society for Implementation Research Collaboration (SIRC) is seeking nominations for the SIRC Mission Award, which recognizes outstanding contributions of collaborative teams in advancing implementation science and practice consistent with the spirit of SIRC's mission.

### **SIRC's Mission:**

*SIRC is an organization dedicated to bridging the gap between implementation research and practice through rigorous and efficient frameworks and methods. SIRC has prioritized contributions from and partnership between researchers and practitioners to advance this mission – both during and between conferences.*

The awardee will be announced at the SIRC 2022 conference in San Diego, CA. Awardees will be invited to present their work through a symposium at SIRC 2024.

### **Deadline for Nomination Letters: Friday, July 1, 2022**

**Instructions for Nominees: Please provide a 1-2 page letter** describing your collaborative team of researchers and practitioners and the work you do together. “Practitioner” may be defined broadly. Examples include local providers, evidence-based practice champions, administrators, policy makers, regional and national provider leaders, and people who consult, facilitate, or purvey the training and expertise of evidence-based practices to agencies. In general, how does the work of your team advance implementation science and practice collaboratively with partnership among researchers and practitioners?

In the letter, please provide a **one-paragraph description** for each of **up to three specific products or outcomes** of your work together (e.g., reports, publications, implementation projects, frameworks, theories, web-based resources, etc. – think broadly!) that exemplify the work your team does to advance implementation science and practice. Briefly describe each product or outcome and how it was developed collaboratively and how it advances implementation science and practice. As a part of the description, you may provide any supporting documentation, such as a link and/or citation to a public report or publication.

Other topics to highlight in the letter include:

- The areas in which you believe your team or organization is innovative and advances implementation science and/or practice;
- How your team has harnessed funding or other resources to do this collaborative work;
- How your work has impacted the individuals who are the intended beneficiaries (e.g., patients, clients, consumers, etc.) of your team's implemented practice(s);
- How your team's work advances health equity;
- What your team or organization plans to do next.
